## **The benefits of becoming a member of the Friends group are:**

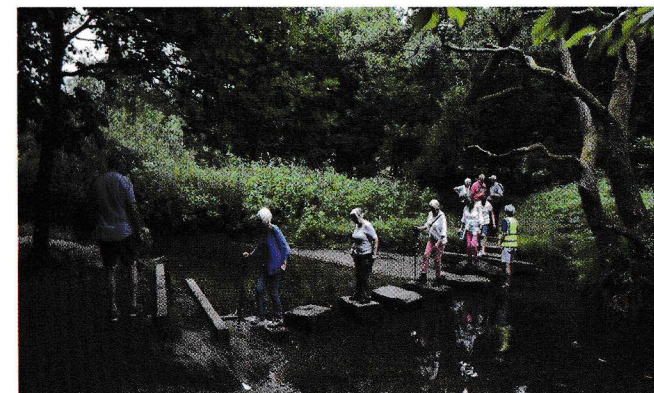
- You become a Member of the Trust and are eligible to vote at the CVPT AGM

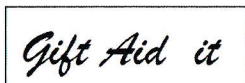
